5. Favorable political and social climate.
The political and social climate seems to be "right" for starting a collaborative project like this one. (The current political and social climate of our region are in a position for the CPN to be successful)

The time is right for this collaborative project.
(The time is right for the work of the CPN.)
7. Mutual respect, understanding, and trust.
People involved in our collaboration always trust one another.
(Do you feel that CPN members trust one another?)
8. Mutual respect, understanding, and trust.
I have a lot of respect for the other people involved in this collaboration.
(I have a lot of respect for the CPN members)
9. Appropriate cross section of members
The people involved in our collaboration represent a cross section of those who have a stake in what we are trying to accomplish.
(The CPN membership represent a cross section of agencies that have a stake in providing quality referrals and person-centered care)
10. Appropriate cross section of members
All the organizations that we need to be members of this collaborative group have become members of the group.

(All the organizations that we need in the CPN have become members of the group or are there others that need to join the CPN for its success?)

11. Members see collaboration as in their self-interest

My organization will benefit from being involved in this collaboration.

(Does your organization benefit from being involved in the CPN?)

12. Ability to compromise

People involved in our collaboration are willing to compromise on important aspects of our project.

(CPN members are willing to compromise on important aspects of our project)

13. Members share a stake in both process and outcome

The organizations that belong to our collaborative group invest the right amount of time in our collaborative efforts.

(CPN Members invest the right amount of time in our efforts)

14. Members share a stake in both process and outcome

Everyone who is a member of our collaborative group wants this project to succeed.

(All CPN members wants our mission to succeed)

15. Members share a stake in both process and outcome

The level of commitment among the collaboration participants is high.

(CPN members display a high level of commitment to our collaborative work)

16. Multiple layers of participation

When the collaborative group makes major decisions, there is always enough time for members to take information back to their organizations to confer with colleagues about what the decision should be.

(When the CPN needs to make a major decision, do you have enough time to confer with your colleagues about what the decision should be?)

17. Multiple layers of participation

Each of the people who participate in decisions in this collaborative group can speak for the entire organization they represent, not just a part.

(As your agency's representative, are you able to make decisions for your whole organization?)

18. Flexibility

There is a lot of flexibility when decisions are made; people are open to discussing different options.

19. Flexibility

People in this collaborative group are open to different approaches to how we can do our work. They are willing to consider different ways of working.

(Members of the CPN are willing to explore new ways to accomplish our goals)

20. Development of clear roles and policy guidelines

People in this collaborative group have a clear sense of their roles and responsibilities.

21. Development of clear roles and policy guidelines
There is a clear process for making decisions among the partners in this collaboration. (The Fist of Five process is used to make decisions)
22. Adaptability
This collaboration is able to adapt to changing conditions, such as fewer funds than expected, changing political climate, or change in leadership.
(The CPN has the ability to adapt as needed)
23. Adaptability
This group has the ability to survive even if it had to make major changes in its plans or add some new members in order to reach its goals. (Would the CPN be able to continue if we added members or had to make major changes, such as in leadership, etc?)
24. Appropriate pace of development
This collaborative group has tried to take on the right amount of work at the right pace. (The CPN has always set an appropriate pace as it developed and continues to develop)
25. Appropriate pace of development
We are currently able to keep up with the work necessary to coordinate all the people, organizations, and activities related to this collaborative project
26. Evaluation and continuous learning
A system exists to monitor and report the activities and/or services of our collaboration. (Unite Us Data, CPN Dashboards, CPN One-Pager)
27. Evaluation and continuous learning
We measure and report the outcomes of our collaboration. (Unite Us data and CPN Dashboards)
28. Evaluations and continuous learning
Information about our activities, services, and outcomes is used by members of the collaborative group to improve our joint work (CPN Strategic Plan and CPN Dashboards)
29. Open and frequent communication
People in this collaboration communicate openly with one another.
30. Open and frequent communication
I am informed as often as I should be about what is going on in the collaboration.
31. Open and frequent communication
The people who lead this collaborative group communicate well with the members.
32. Established informal relationship and communication links
Communication among the people in this collaborative group happens both at formal meetings and in informal ways. (Do you feel comfortable to reach out to CPN members outside of meeting times?)
33. Established informal relationship and communication links
I personally have informal conversations about the project with others who are

involved in this collaborative group.

(Do you and/or your organization have informal conversations about the project with others in the CPN?)

34. Concrete, attainable goals and objectives

I have a clear understanding of what our collaboration is trying to accomplish(CPN goals are to build relationships with clients we serve and each other. Provide person centered care through quality online referrals.)

35. Concrete, attainable goals and objectives

People in our collaborative group know and understand our goals. (Do you feel that you understand the goals of the CPN?)

36. Concrete, attainable goals and objectives

People in our collaborative group have established reasonable goals. (The CPN has established reasonable goals)

37. Shared Vision

The people in this collaborative group are dedicated to the idea that we can make this project work. (CPN members are dedicated to the CPN Vision)

38. Shared Vision

My ideas about what we want to accomplish with this collaboration seem to be the same as the ideas of others.

39. Unique purpose

What we are trying to accomplish with our collaborative project would be difficult for any single organization to accomplish by itself. (It would be hard for any single organization to provide person centered care and use the Unite Us referral platform, at the magnitude that the CPN has)

40. Unique purpose

No other organization in the community is trying to do exactly what we are trying to do. (No other organization is utilizing a referral platform to provide person centered care)

41. Sufficient funds, staff, materials, and time

Our collaborative group has adequate funds to do what it wants to accomplish. (The CPN has adequate funds to accomplish our vision)

42. Sufficient funds, staff, materials, and time

Our collaborative group has adequate "people power" to do what it wants to accomplish

43. Skilled leadership

The people in leadership positions for this collaboration have good skills for working with other people and organizations.

44. Engaged stakeholders

Our collaborative group engages other stakeholders, outside of the group, as much as we should. (Out of network resource and referral sharing)
